New Business:

The other issue raised was whether or not we need to invite all candidates to participate. The consensus at the table was yes; however, it may warrant discussion when asked to facilitate again.

Halloween Storefront – we will not be taking part in this.

Christmas Storefront – we will be taking part int his, and will look at potentially partner with the Christmas on the LaHave committee. We will also look at entering the parade, and a couple of Board members will look into whether or not they can supply equipment like a trailer.

Jeff Langille let the Board know that his colleague Kim has left Taylor Flooring, so she will not be an alternate for him going forward.

Rob Simpson spoke from the audience to let us know about the Lunenburg County Health Board partnering with Sobey's for a sensory awareness time each Sunday allowing people with these types of sensitivities to be able to shop in more comfort. Rob asked us to promote this through the membership as something that should be considered in other businesses.
